GENERAL EXPLANATIONS

In the 11th article of the Law, certain rights have been provided to personal data owners (hereinafter referred to as "data owners") regarding the processing of personal data. Under Law No. 6698 on Protection of Personal Data ("Law"), "personal data owners" are defined as real or living persons. In accordance with the first paragraph of Article 13 of the Law, the applicants who are responsible for data related to these rights must be notified in writing or by other methods determined by the Board of Personal Data Protection ("Board"). In this context, the applications submitted to our Company as "written" are required to be forwarded **by registered and reply-paid letter** with the use of this form.
