GENERAL REMARKS

Article 11 of the Law No. 6698 on the Protection of Personal Data Protection ("KVK Law") has granted certain rights to personal data owners defined as data subject (hereinafter referred to as the "Applicant") to make requests regarding the processing of their personal data.

- through a notary public,
- May be signed by the Applicant with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 and sent to the registered e-mail address of the

Company.

In addition, in case of the announcement of other methods by the Board, it will also be announced by our company how the applications will be received through these methods.

Your applications submitted to us shall be answered depending on the nature of the demand and within thirty days from the date your demand is received by us pursuant to Article 13 paragraph 2 of the KVK Law. Our responses shall be sent to you in writing or electronically pursuant to Article 13 of the KVK Law.
